Due to current infrastructure and economic constraints, the operator requests approval to suspend completion operations indefinitely on the Flo Jo #94.

The Flo Jo #94 is tied into the Sesamee Street Gathering system. This infrastructure is insufficient to handle current production volumes of natural gas. Construction will begin next week on 4 miles of new 10" compressor suction line. This expansion will create additional room for gas sales from new wells to be added to the system.

Once the expansion project is finished and improvements in the economy occur, completion operations (fracture stimulations, installation of production facilities and recontouring and re-seeding of disturbed areas) will resume.
