Change the currently permitted blow out preventer configuration to 9" 2,000 psi dual ram configuration. The previous configuration used a 7-1/16" 2,000 psi dual ram BOP. ✓

The new configuration will allow for a test plug to be set in the casing head such that testing of the BOP stack can be done in a conventional manner. ✓

Change the hole size for the production casing to 7-7/8" (the previously permitted hole size was 7"). The cement volume will be adjusted to compensate for the increased hole size to allow for circulation of cement to the surface. ✓
