Spot 20 cu ft. Type III cement on top of retainer to cover 1160'-980', Fruitland top 1150'.
Perforate 4 squeeze holes @ 647' (50' below Kirtland top).
Pump down casing with 20 bbls water. Would not circulate out bradenhead.
Pumped 92 cu. ft. Type III cement down casing and displaced to 300'.
Shut in overnight.
Tag cement @ 296' with tubing.
Perforate 4 holes @ 154'.
Pump 55 cu. ft. Type III cement down casing.
