Primary cement job on well yielded no cement to surface. CBL log showed TOC at 760'. A void was present across L Shot squeeze holes at 6600' and 6100'. Pumped 80 sx (16.8 bbls) class "H" cement under retainer into holes at 6600'. Pumped 25 sx (5 bbls) Class "H" into holes at 6100'. Pressure tested holes at 6600' to 1500 psi- OK. Pumped 50 sx (10.5 bbls) Class "H" cement into holes at 6100' under retainer. Pressure tested holes to 1500 psi- OK.
