BP America Production Company request permission to amend Surface Commingle Order PC-1103-A; approved June 6, 2004. It is our intent to add the **McCulley LS 4 S** Fruitland Coal. The McCulley LS 8 (PC) was P&A'd 12/14/09. (see attached schematic)

Surface commingling production from the existing McCulley LS 2A (MV/CH) (DHC 1494 AZ) and **McCulley LS 4 S** (FC) will not reduce the economic life of the wells.

After separation the production from each of the 2 wells will be metered individually prior to commingling. The commingled gas will then be sent through compression prior to entering the sales meter. The difference between what is measured prior to commingling & what is sold through the sales meter is the fuel usage. This fuel usage is allocated back to each well based on the well production. (see attached schematic)

The working interest, royalty and overriding royalty interest owners in the subject wells are identical. (see land letter attached) The proposed commingling of production is to reduce operating expenses between the 2 wells and will result in increased economic life of the wells.

BLM has also been notified of this proposal by copy of BLM Form 3160-5.
