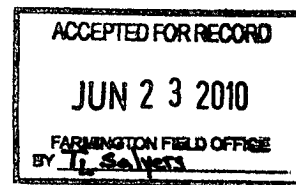

Cement with 220 sks Class G, 2% CaCl2, 1/4#/sk floccle (264 cu.ft.). Plug down @ 12:45 am on 06/06/10. Circulate 16 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing to 750 psi - 30 minutes - ok. Test BOP to 250 psi, low - 15 minutes and to 2000 psi, high - 15 minutes - ok.
