05/25/10 TIH and perforate 6171' - 6368' - 1 spf, 0.34", 30 holes total.

05/29/10 Frac Mancos perfs with 63,000 gals Delta 200 and 150,00# 20/40 sand.

05/30-07/10/10 Flow back frac. Clean out with air and foam. Drill out composite plug.

07/14/10 TIH with 2.375" tubing, set @ 7362'. ND BOP. NUWH, return to production.
