Pressure test 5 1/2" csg to 3000# for 30 mins, held ok. Ran GR-CCL-CNL logs from PBTD 956' to surface. Swab 5 1/2" csg down to 500'. Perforate Fruitland Coal from 772'-790' & 722'-726' w/4 spf (total 76 holes). Ran in hole w/bridge plug and packer on 2 3/8" tubing. Break down and acidize perforations 772'-790' w/400 gals 15% HCL. Break down and acidize perforations 722'-726' w/100 gals 15% HCL. Frac Fruitland Coal 722'-790" w/53,800 gals cross-linked gelled water and 88,960 lbs 20/40 sand.
