Plug and Abandonment Report

Notified BLM on 9/17/10

Plugging Summary:

09/17/10 MOL and RU. SDFD.

09/20/10 Open up well and blow down 150 PSI casing pressure. Round trip 2.875" gauge ring to 2156'. RIH and set 2.875" PlugWell CIBP at 2153'. ND wellhead. NU BOP and test. RU on 7.625" bradenhead. Load with ½ bbl of water. Pressure test bradenhead to 500 PSI for 10 minutes. TIH with 1.25" tubing and tag BP at 2153'. Circulate well clean with 11 bbls of water. Pressure test casing to 1000 PSI for 10 minutes. Oscar Torres, BLM representative, approved procedure change.

Plug #1 and #2 with CIBP at 2153', spot 25 sxs Class B cement (29.5 cf) inside casing above CIBP up to 1243' to isolate the Pictured Cliffs interval and cover the Fruitland, Kirtland and Ojo Alamo tops. PUH to 291'.

Plug #3 with 13 sxs Class B cement (15.3 cf) from 291' to surface, circulate good cement returns out the casing valve. ND BOP. Dig out wellhead. SDFD.

09/21/10 Issue Hot Work Permit. Cut off wellhead. Found cement down 5' in annulus and 40' in 2.875" casing.

Plug #4 mix and pump 16 sxs Class B cement (18.8 cf) to fill annulus and 2.875" casing; install P&A marker. RD and MOL.

Oscar Torres, BLM representative, was on location.
