Pumped 50sx(81cf-14bbls) Type I-II cmt w/ 20% Flyash. Drop plug. Started displacement & cmt locked up, no cmt to surface. Top out 7" surface csg by pumping w/ 9sx(13cf-2bbls) neat cmt. Circ 1bbl cmt to surface. WOC. ND BOPE. RD RR @ 15:00hrs on 1/13/11.

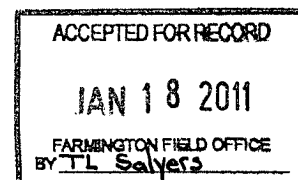
