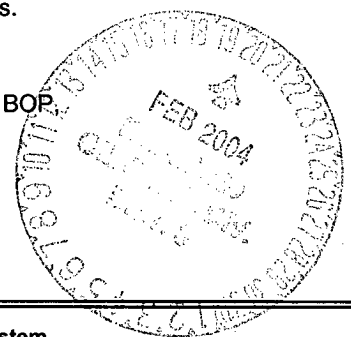

1/23/04 MIRU Key #27. NU BOPs, PT casing and blind rams to 300 psi and 1800 psi for 30 minutes. Good test. RIH w/6-1/4" bit & drilled out cement shoe & then formation to 3772'. TD reached 1/26/04. Circ. hole. RIH w/4-1/2", 11.6#, 1-80 LT&C casing and set @ 3765'. RU Schlumberger to cement. Pumped 10 bbls gel w/2# per bbl cement followed w/40 sx 9.5 Litecrete w/50% excess. Dropped plug and displaced w/58.4 bbls 2% KCL. Plug down @ 1710 hrs. RD Schlumberger. ND BOP set slips and cut off casing. RD & released rig @ 1300 hrs 1/28/04. Will show casing PT and TOC on next report.
