Cmdt w/25 sx Class "B" scavenger cmt w/3% calcium chloride, 0.25 pps Celloflake, 5 pps LCM-1, 0.4% fluid loss, 0.4% sodium metasilicate, 8% gel (78 cu.ft.). Tailed w/306 sx Class "B" Type III cmt w/1% calcium chloride, 0.25 pps Celloflake, 0.2% fluid loss (606 cu.ft.). Displace w/wtr. WOC. PT csg to 3800 psi/15 min, OK. ND BOP. NU WH. RD. Rig released.
