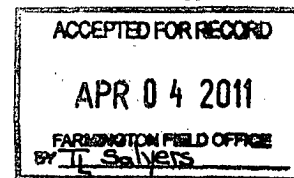

On 3/19/2011 XTO pressure tested surface csg to 1000 psi. Did not Test. Set packer @ 315' & tested Surface Csg to 1000 psi for 30 min. Good Test.
