Cmt with lead cmt 330 sx, 13 ppg, 1.43 yield, (472 cu ft) 50/50 Poz Premium + 0/125#/sk Poly-E-flake + 0.3% Halad@-9 + 2.5#/sk Gilsonite followed by tail cmt 515 sx, 15.8 ppg, 1.16 yield, (597 cu ft) class G Premium + 0.125#/sk Poly-E-flake + 1% CaCl2. Circulated 45 bbls cmt to surface.
