Proposed perforations are: MV - 3098' - 5600' ; DK - 7242' - 7539' These perforations are in TVD.

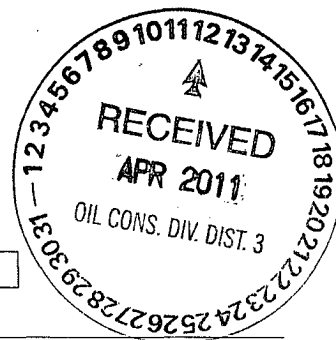
