Cement 7" casing as follows: (lead) 280 sx Type III cement w/3% extender, 1/4 pps Celloflake & 2% Phenoseal mixed @ 11.4 ppg, 2.88 cuft/sx & 17.89 gal/sx, followed by (tail) 100 sx Type III cement w/1/4 pps Celloflake & 2% Phenoseal mixed @ 14.8 ppg, 1.32 cuft/sx & 6.3 sx.

Volumes include 50% excess.

Circulate cement to surface. Drill well to TD as originally proposed.
