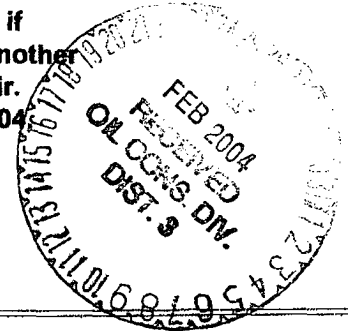

**This well is a good producer. The main entry road comes up the first wash inside Colorado on Ute land and then crosses into New Mexico. Someone has put up a fence at the border and we no longer have rig access to the well. We need to meet with the Utes and see if they will let us put in a gate at the border. If they do not let us do that, then there is another access road in from New Mexico which is in terrible condition and expensive to repair. Because of these problems, we would like to return this well to production by 07/31/04**
