Cellophane Flake (lost circulation additive), 0.3961 cuft/ft OH, 0.1% D46 antifoam. 100% excess
Slurry Properties: Density 15.2; Yield 1.27; Water 5.8 (gal/sk)

However, should conditions change, BP request as an alternate to conventional drilling program, to drill the subject well with air/air mist in lieu of drilling mud and preset the surface casing
