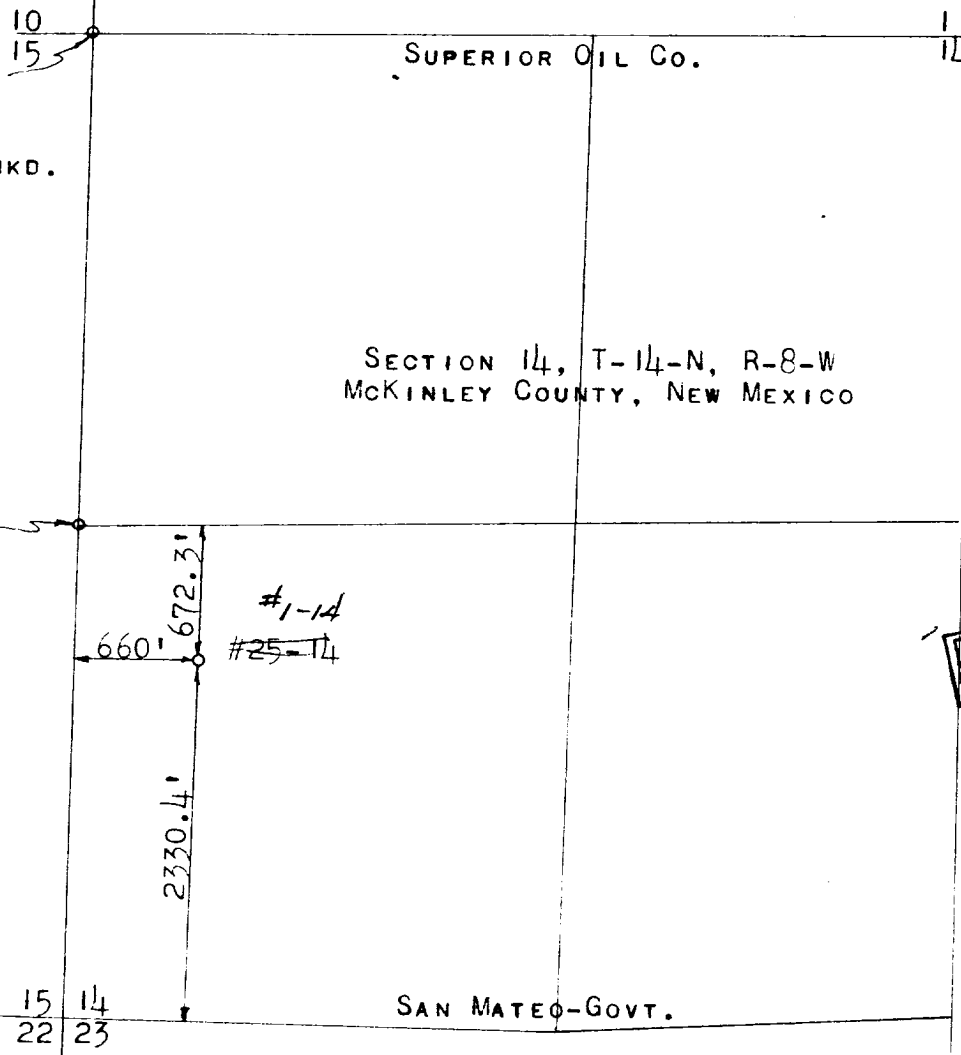

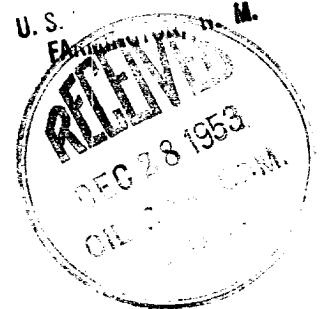
BRASS CAM MKD.

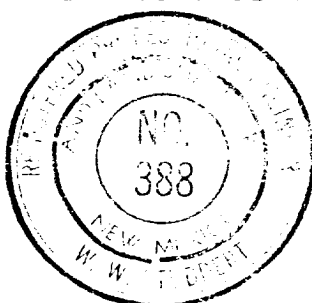
