CONVERSION TO WATER-WELL

C. W. Horstmeier, being first duly sworn according to law, upon his oath deposes and says:

1. That he is Vice President of SINCLAIR OIL & GAS COMPANY

whose address is P. O. Box 521, Tulsa 2, Oklahoma.

2. That SINCLAIR OIL & GAS COMPANY is the operator of a well drilled on land be-

longing to Jean Carica, whose address is 123 North 1st Street  
(Landowner)

Grants, New Mexico, said well being drilled to test for hydrocarbons and/or carbon dioxide gas and described as the 167 North Carica No. 1, being located 660 feet from the North line and 660 feet from the East line of Section 28, Town-ship 18 North, Range 7 West, NMPM, McKinley County, New Mexico.

3. That said well was drilled to a total depth of 2543 feet, and that casing has been set and cemented as follows:

**8-5/8" OD casing set at 32 ft. and cemented with 20 sacks cement.**

4. That operator and landowner have made an agreement whereby operator (~~is~~) (is not) to back fill pits, level location, and clear it of all junk. The agreement further provides that operator is to plug said well back to a plugged-back total depth of 800 feet and transfer well to landowner for his use as a water-well. Operator will leave casing in the well as follows:

**8-5/8" OD casing at 32 ft. Top of hole is capped with cement and regulation marker is installed.**

5. That when operator has complied with the provisions of Paragraph 4 above it will so notify the Oil Conservation Commission of the State of New Mexico on Commission Form C-103, together with a signed statement from the landowner that the provisions of Paragraph 4 above have been complied with to his satisfaction.
