LOS ANGELES, CALIFORNIA, said well being drilled for hydrocarbons and/or carbon
dioxide gas and described as the SINCLAIR-SANT No. 1, being located 620
feet from the NORTH line and 755 feet from the EAST line of Section 28, Town-

3. That said well was drilled to a total depth of 4242 feet, and that casing has

Paragraph 4 above have been complied with to his satisfaction.
