**TEST # 2 (2 packers) 2900-3000 (GRAB) Strong blow of air to surface immediately increasing to stronger for 1 hour; medium blow for 15 minutes and weak blow for 15 minutes. Tool open 15 hours and began swelling. Drill pipe clogged at 700' by lost circulation material. Put on sharp steel rod and penetrated; then agitated, and liquid in drill pipe rose 100', to 600' from surface. Sub attempted w/undersize rubbers and brought out 500' drilling mud cut by L.C. material. Correct size rubbers obtained and swabbed for 1 hour and 30 minutes recovering much drilling mud. Last drilling mud in annulus because sub pushed circulating pin out of test tool. Recovered 3000' drilling mud. IHP 1805, L&IP 1305 (30"), BTP 750, FFF 1250, FBIP none and FHP 1355.**

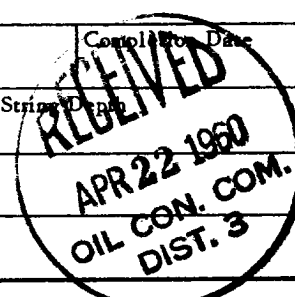
