Gentlemen:

We are transmitting herewith, in quintuplicate, Form C-101, "Notice of Intention to Drill," covering this company's Santa Fe 199 Tucker Pass, Well No. 1, located at 660' from the South line and 900' from the East line of Sec. 6-19N-8W, McKinley County, New Mexico, and which is an application for an exception to Rule 104(b).

It was necessary to move this location 240' West of what would have been a regular location due to the regular location falling upon sheer sand stone ledges, as indicated on Form C-128, Well Location Plat, which is attached to all copies of Form C-101. It is requested that we be granted an exception to Rule 104(b) since the necessity for the unorthodox location is based on topographical conditions and the ownership of all oil and gas leases within a radius of 660' of the proposed location is common with the ownership of the oil and gas leases over the proposed location.

Reference is made to your letter of October 5, 1956 applying for a non-standard location in Section 6-19N-8W, McKinley County, New Mexico.

We are attaching a copy of Order R-855 which amends Rule 104. This order was signed on August 10, 1956 and supersedes the original Rule 104. You will note from Paragraph B of this Order that a wild-cat well may be located 330 feet from a 40-acre sub-division boundary. As your location is 660 feet from the South line and 900 feet from the East line it is no closer than 420 feet to any 40-acre boundary.
