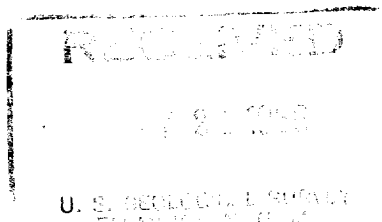
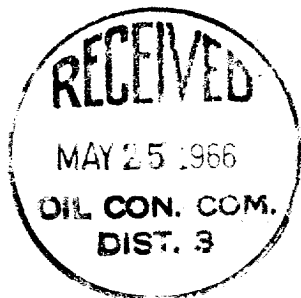

Instructions
