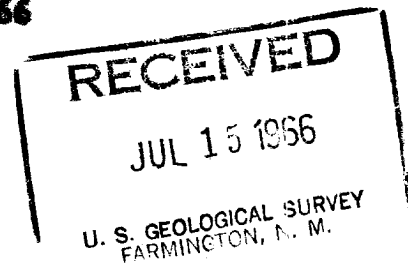

## Instructions
