Drilled a 9 7/8" hole to 420' and set 420' of 7" casing into Point Lookout. Casing was cemented with 150 sx Class A cement w/2% CaCl₂ and cement brought back to the surface. A 6 1/2" hole was then drilled to 1604' into the Massive Gallup.

Location was cleaned and leveled.

Left hole as water well as per landowners request.
