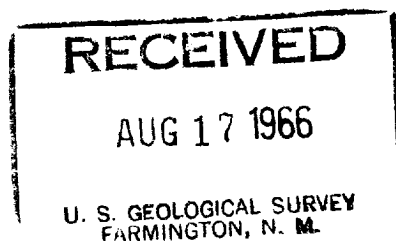
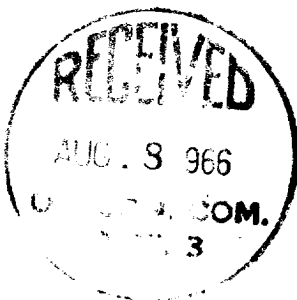

Instructions

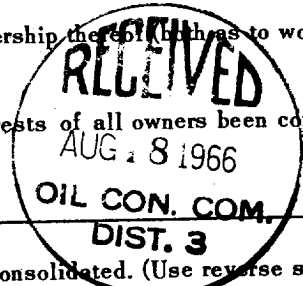
