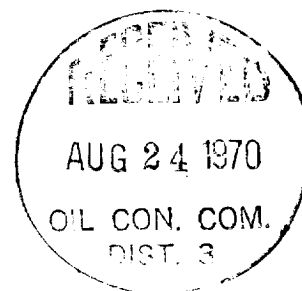

Convert to water injection. Move in service unit, pull rods and tubing, clean out to 1751' FBTD, perforate with 2 shots per ft. 1702' - 1708' and with 4 shots per ft. 1716-19, 1722' - 25' run Baker LOC set packer on 2-3/8" plastic coated tubing, acidize perforations, swab acid, treat with 500 gals. P-121 solvent and put well on injection.
