After setting 13 3/8" OD, 48#/ft., H-40, ST&C, casing at 277' RKB and testing it. Drilled 8 3/4" hole to 4,919', the total depth. Total depth was reached on 4-2-67. Ran Logs. Now planning to plug and abandon well. Verbal approval was obtained from Mr. Emery C. Arnold of your Astec office by off Mr. Otto Barton on 4-3-67. Cement plugs are to be set as shown below:  
Plug No.1, A 100' cement plug from 3,640' to 3,740'.  
Plug No.2, A 100' cement plug from 3,250' to 3,350'.  
Plug No.3, A 150' cement plug from 220' to 370'.  
Plug No.4, A 5 sack cement plug in the top of the surface casing. A mud of 9.5#/gal weight shall be left between the plugs. A marker will be set in cement.
