Squeezed perf's @ 1620' - 1649' w/50 Sx class "B" cement w/2% CACL2, 0.2% Halad-9. Final pressure -1900#. WOC 12 hrs. Perforated the Lower Hospah formation from 1674' - 1698' w/4 JSPF. RIH w/7" circulating wash tool, set @ 1702', & pressure tstd to 1000# for 30 min-held ok. Acidized perf's w/24 bbls 15% MCA acid. Swabbed back load. NDBOP. Installed wellhead, ran tbg & sub pump, returned well to production.

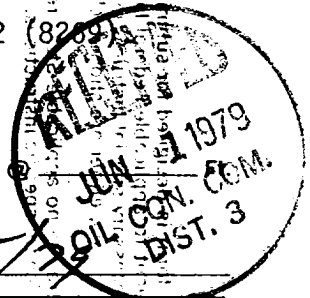
