Spudded 10:00 AM 4-24-70. Drilled 12-1/4" hole to 75' RKB. Set 2 joints 8-5/8" 24# H-40 ST&C surface casing at 73' RKB with 50 sacks common cement plus 2% CaCl. Cement circulated to surface.

Drilled 7-7/8" hole to 1558' RKB and ran Schlumberger IES Log.

Ran 49 joints 5-1/2" 14# K-55 casing with Larkin float shoe and Larkin coupling insert float in top of bottom joint, 4 short bow latch-on centralizers, and 50' rotating scratchers. Set at 1558' RKB with 100 sacks common cement. Plug down at 3:30 AM 4-26-70.

Preparing to drill in with power swivel for open hole completion.
