Spudded 9:00 AM 5-18-70. Drilled 9-7/8" hole to 76' RKB. Set two joints 7" surface casing at 75' RKB with 40 sacks common cement plus 2% CaCl. Cement circulated to surface.

Drilled 6-1/4" hole to 1550' RKB and ran Schlumberger IES Log to 1550' RKB.

Ran 48 joints 4-1/2" 9.5# K-55 casing with insert float, 100' rotating scratchers, and 8 centralizers. Set at 1549' RKB with 65 sacks common cement. Plug down at 1:40 PM 5-19-70.

Will run Gamma Ray Neutron Log and perforate for completion as injection well.
