Moved in completion 11-3-70, tested casing & BOP to 1500 psi, held OK. Cleaned out to PBTD of 2782', perforated 2736 to 2742' w/2 shots per ft., acidized with 500 gals 15% HCL, ran 88 jts of 2-3/8" EUE tubing, landed at 2718', swabbed, installed pumping unit, ran rods with 1-1/2" rod pump. Well tested 11-16-70, 24 hours, 102 Bbls. oil, 30 Bbls. water, 61 MCF, GOR 600, Gravity 54°.
