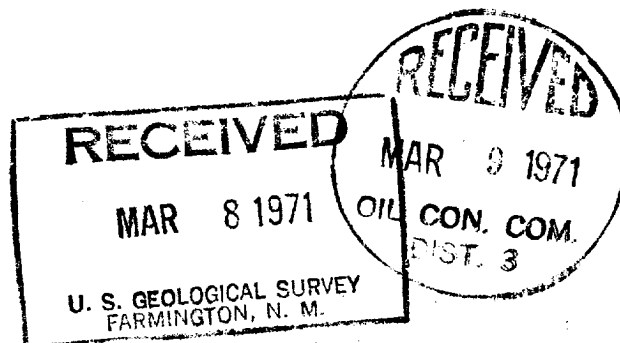

Well spudded 2-24-71 with 12-1/4" hole, drilled to T.D. of 76', Ran 2 jts of 8-5/8" 24# casing, Landed at 76', cemented with 40 sacks, circulated. Tested casing and BOP to 1000 psi, held O.K. Drilled out with 7-7/8" hole to TD of 2810' on 2-27-71, Logged. Ran 57 jts of 5-1/2" 15.5# casing Landed at 2810'. Cemented with 300 sacks. Now waiting on completion unit.
