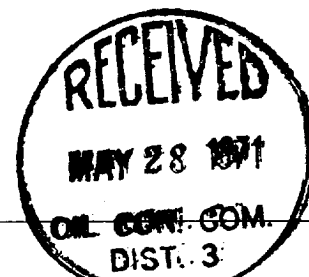

The location has been cleaned and leveled, pits backfilled and a regulation dry hole marker has been erected.



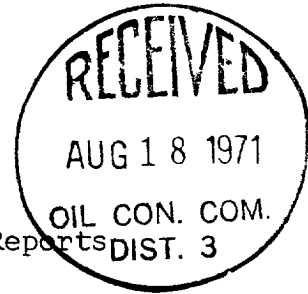

Gentlemen:

Form C-103, Notice of Intention to Plug, your Red Mountain #1  
Lease Well No.  
D-31-20N-9W was approved May 12, 1971. Your  
Unit S-T-R  
subsequent notice of plugging cannot be approved until a commission representa-  
tive has made an inspection of the location to see:

- (1) all pits have been filled and leveled;
- (2) a steel marker, 4" in diameter and approximately 4' above mean ground level, must be set in concrete, this marker must have the quarter-quarter section or unit designation, section, township and range numbers, which shall be permanently stenciled or welded on the marker;
- (3) the location shall be cleared and cleaned of all junk;
- (4) the dead man wires must be cut.

The above are the minimum requirements.
