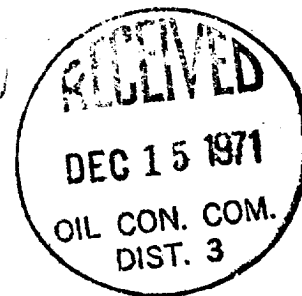

Instructions

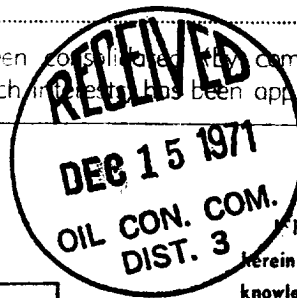

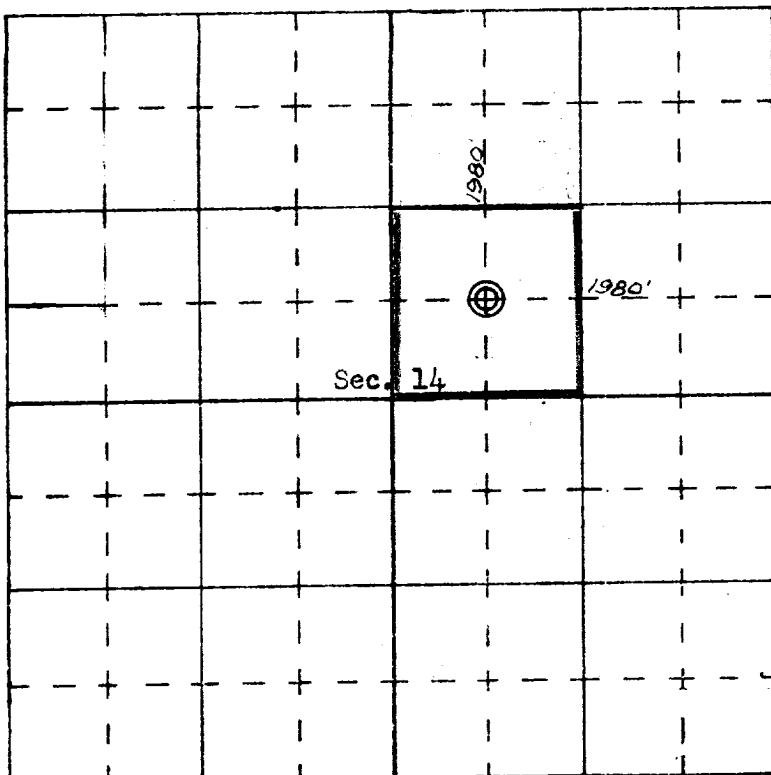
