Gentlemen:

We have received approval for bond No. AE 71174 07 to cover the K & W Oil Company for a well located SE/4 NW/4 Section 32, Township 20 North, Range 9 West, McKinley County. The well currently located in that tract, the Louis M. Wymond #83 Jaco, is covered by bond No. AE 71160 25.

It was my understanding when Mr. Wymond and I discussed this problem that he was to obtain a bond to replace the Jaco, Inc. bond for the Jaco Slaughter #55-Y located 390' from the North line and 960' from the West line of Section 32, Township 20 North, Range 9 West.

I talked to a lady at the Schreiber Insurance Agency near the end of June and explained my understanding of this problem. I understood that she planned to issue a corrected bond about that time.
