May 21-Drilled 12 1/4 hole to 117' and ran 105' of 8 5/8-20# casing--cemented with 100 sax cement--circulated OK.

May 31-Reached TD of 3778' in 7 7/8" hole--logged with Dual Induction-Laterolog & Density.

June 1-Ran 105 jts. of 5 1/2-14# casing to 3775' and cemented with 75 sax of 50-50 Class C & pozmix, with 2% gel and 12 1/2# Kolite. Temperature survey shows top of cement at 3325'. Waiting on completion rig.
