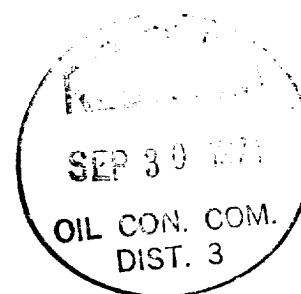

Well spudded 9-23-71 with 12-1/4" hole and drilled to T.D. of 68'. Ran 2 Jts. of 8-5/8" 24# casing landed at 68' cemented with 40 sacks, circulated.

Tested casing and B.O.P. to 1000 psi, held ok. Drilled out with 7-7/8" hole on 9-25-71 and drilling at 225' on 9-27-71.
