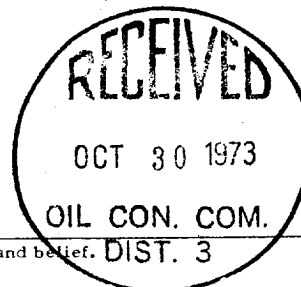

Well spudded 9/8/73 @ 9:45 a.m. Drilled with native mud to T.D. 754'. Cored Hospah sandstone zone 732-47'.

On 9/9/73 ran and set 23 joints, 736', 4½", 10.5#, K-55, R-2 used casing at 736' GR with Baker canvas insert metal petal basket on bottom. Left open hole 736-54. Cemented with 65 sx class "A" cement. Plug pumped down @ 4:00 p.m. 9/9/73. Held pressure on casing at 700 PSI for 18 hours with no bleedoff. Began drilling out plug and shoe at 10:00 a.m. 9/10/73. Ran 737.5' 2 3/8", J-55, 4.7# tubing, R-2, set at 736' GR. Swab for 2½ hours. Ran 2" insert pump on 3/4" rods, nipped up & S.I., waiting on pumping unit, flow lines and tank.
