Drilled 7 7/8" hole to TD 5207, ran electric logs. Preparing to plug and abandon 31 Dec 73, cement plugs as follows: 35 sx 5100'-5000', 35 sx. 4200'-4100', 35 sx. 3900'-3800', 35 sx. 2200'-2100', 35 sx. 2000'-1900', 35 sx. 500'-400', 20 sx. 250'-200', 10 sx. 20'-0'.
