Spud 4/26/74. Drilled 6½" hole to 428'. Cored from 428-48'. Reamed core hole to 6½" and drilled to 458' on 5/3/74. Ran Century Geophysical Log. Ran 22 joints, 424', 4½" 11# casing, set at 424' BGL w/Rector Cement basket on bottom. Cement w/35 sacks regular cement. On 5/9/74 drilled out plug. Pressure tested at 650 PSI & held for 30 minutes. No leaks. Ran 14 jts, 2 3/8 EUE tubing and swabbed well. Swab trace of oil and 3 BW/hr. Menefee zone apparently flooded out. Pulled tubing. S.D. will convert to water injection well for Red Mountain Mesaverde waterflood.
