Spud 8/22/74. Drilled 6½" hole with rotary tools to 738'. August 29th cut Core No. 1 738-58'. Full recovery; oil sand 744'-56'. Reamed core hole to 6½" from 738'-58' and drilled to 759'. Ran Century Geophysical Log (SP - GR - Resistivity) 0'-759'. August 31st ran 24 jts (744') 4½" - 9.5# casing w/Reactor cement basket on bottom. Cemented @ 744' G.L. w/75 sx class A cement. Cement circulated. Plug down @ 1:30 p.m. WOC 72 hrs. Drilled out top plug and cement and washed to bottom @ 759'. No leaks. Ran 754' of 2 3/8" EUE tubing and set in Larkin Type Q tubing head. Pressured up to 700 PSI and held for 30 minutes. No leaks. Ran 2"x 1½" rod pump and set in seating nipple @ 754'. Set pump jack. Hooked up electricity and layed oil lines to battery. Began pumping 9/10/74. Sept. 24th ran 24 hr pump test. Pumped 8 BO and 30 BW. Complete 9/25/74
