This well is currently in long term shut-in status. Request that this status be continued for additional nine (9) month period.

We are currently making application to the Environmental Protection Agency, Region 9, San Francisco, California for permission to inject water into the Point Lookout Interval (approximately 2825-50' subsurface) of the Mesa Verde Formation in the subject area utilizing our Noo Navajo #2 Well (NW/4NE/4, Sec. 13, T20N, R6W, NMPM) as a water injection well.

The subject well is a direct offset to the proposed injection well and is completed in this interval. Hopefully it will benefit from this secondary recovery project.

One other well on this lease is currently producing (Noo Navajo #1, NE/4SE/4, Sec. 13, T20N, R6W).

This well was drilled in 1976. Cement was circulated to surface and no contamination of other formations is expected.
