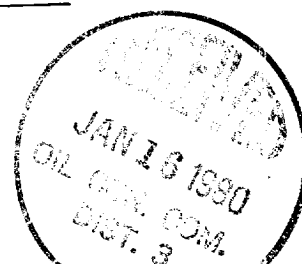
Verbal permission was obtained from Mr. L. Kendrick of the New Mexico Oil & Gas Conservation Commission to plug and abandon the well as follows:
