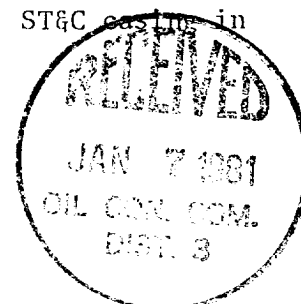

Plug #3 from 2750'-2650' - 29 sacks
Plug #4 from 1840'-1740' - 29 sacks
Plug #5 from 317'- 204' - 33 sacks

Nipple down BOP. Released rig. Left 8 5/8", 24#, K-55, ST&C casing in hole (254' KB).
Set 20 sacks cement at surface with dry hole marker.
Cleaning location and reserve pit (has been fenced).
