Spudded 13 3/8" hole at 11:00 PM, 5-30-81. Drilled to 92 feet and set 2 joints of 10 3/4", 52# casing, Total equipment 78' set at 89'. Cemented w. 40 sxs of Class B w/ 2% CaCl<sub>2</sub>. POB at 2:30 PM 5-31-81. After 12 hours drilled out cement and tested casing with 475 psi for 30", held OK. Drilled 6 3/4" hole to a TD of 1680'. Ran DST #1 from 1590 to 1680'. Open 15"-slight blow throughout test, SI 30", Second open for 30"-no blow, SI for 60". Recovered 30' of drilling mud. IF 20psi, ISI 20 psi, 2nd flow 20 psi, 2nd SI 305 psi, ihp 725, fhp 659 psi.

Ran ES and CL logs and prep to abandon well.
