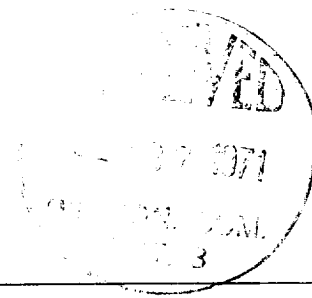
- 9-3-71: Spotted 25-sack cement plug (134') from 1550' back to 1416'.
 9-9-71: Perforated with McCullough 4 jet holes at 430' GL. Ran 7" Halliburton cast iron retainer on wire line and set at 207'.
 9-10-71: Stung 2-3/8" tubing into retainer at 207'. Pumped 80 sacks of common cement through perforations at 430' with 500 psi. Left cement in casing from 430' back to 277' (223' plug). Pulled tubing and stinger.
 9-14-71: Set 10' cement plug in top and installed dry hole marker.
 Well plugged and abandoned.

Form C-103, Notice of Intention to Plug, your *Hospah Sand Unit* *11*
Lease Well No.
F - 1-17N-9W was approved *9-22-71*. Your
Unit S-T-R
subsequent notice of plugging cannot be approved until a commission representa-
tive has made an inspection of the location to see:

- (1) all pits have been filled and leveled;
- (2) a steel marker, 4" in diameter and approximately 4' above mean ground level, must be set in concrete, this marker must have the quarter-quarter section or unit designation, section, township and range numbers, which shall be permanently stenciled or welded on the marker;
- (3) the location shall be cleared and cleaned of all junk;
- (4) the dead man wires must be cut.

The above are the minimum requirements.
