2. Drill surface hole to 120'. Cement 8 5/8", 24#, J-55 casing at 120' cemented to surface.
3. Drill 7 7/8" hole to total depth, estimated at 3250'.
4. Run electric logs and micrologs for decision to complete.
5. If logs satisfactory, run 4 1/2", 116, #J-55 casing to total depth and cement with 250 sax.
6. Productive intervals to be perforated and fraced.

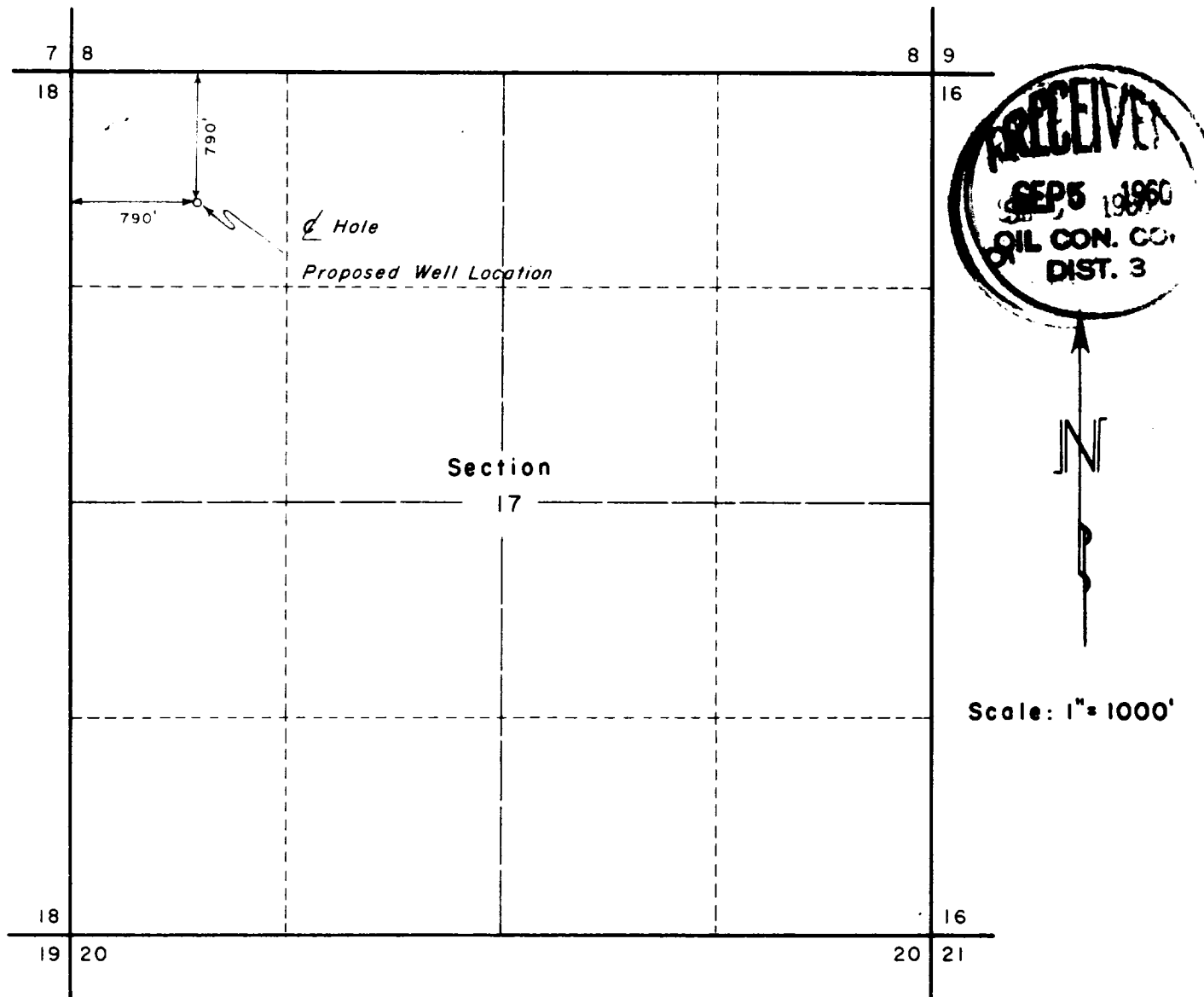

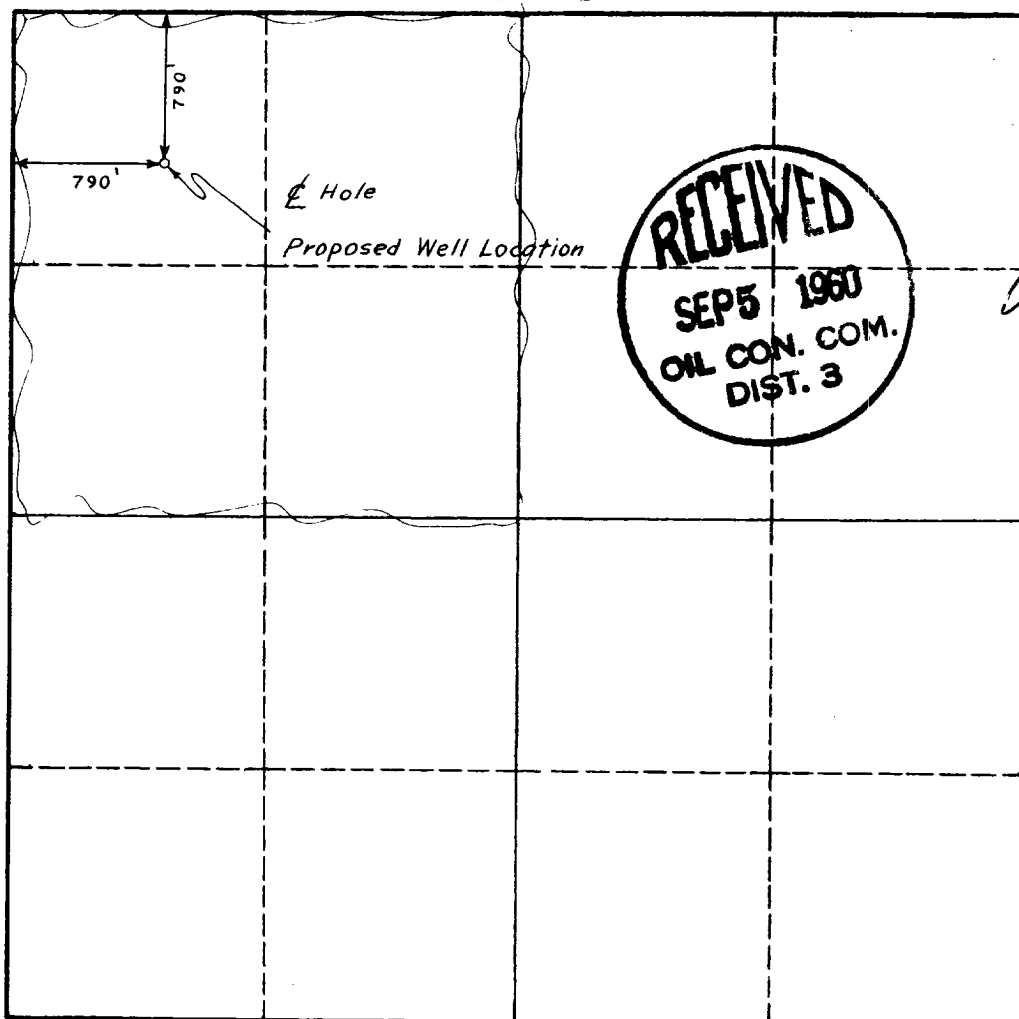
