Dear Sir:

We have just received three copies of Notice of Intention to Drill on your #1 Jicarilla-Apache Well in the NE¹₄ Section 11-23N-4W.

As this well is located on Indian Land the Notice of Intention to Drill should be filed on Federal Form 9-331 with the U.S.C.S. Office, Box 965, Farmington, N.M. I believe they require five copies of this form. Oil Commission Form C-128, Well Location and Acreage Dedication Plat should be filed with the Federal Notice of Intention to Drill. This form should also be submitted in quintuplicate. Form C-128 should be signed by the surveyor as regards the location of the well and all the questions regarding land ownership should be answered and the form signed by the operator's representative. The 160 acres which you are dedicating to this well should be outlined. I presume this would be the NE¹₄ Section 11.
